Attached, please find the proofs of your articles submitted to the WTE&TE, Vol.15, No.1.

The article marked 15-Purnamawati should have not been submitted to us due to its terribly poor quality. As per normal procedure, we asked three international referees to assess the paper. It looks to us that they did not pick up all the serious problems in the article. We then asked one of our editors to review the text in terms of the language used. At one point of correcting the article he declined the work as he was unable to understand the language used, and complained about the terminology used. In the future, I would suggest that you use the correct glossary of the terms used in tackling such topics and not to make up your own terminology.

It has taken two other highly skilled and experienced editors several hours to bring this article to the state as per the attached PDF version. Moreover, it was discovered that the way in which you applied citations was totally incorrect. We have marked the places where you make some attribution to particular persons (given their names), but such names do not appear in the list of references. Marked in red are such instances, where proper references must be provided.

We should have rejected this paper all together and we will this in the future, if we receive such a poorly prepared article. We have done this huge work on this occasion, but will not in the future.

Would you please review the papers and make necessary changes/additions/amendments directly on the PDF versions, and send them back to me by Monday, 20 March 2017.

Taking into considerations the substantial changes to the article (15-Purnamawati) performed by us, would you please fill in, sign and submit the attached Submission Declaration Form used in such instances?
