### Reviewer #1: GENERAL OVERVIEW AND MAIN CONTRIBUTIONS:

The authors of this paper present a dataset of 250 responses to the survey "Online learning" of students in the Faculty of Mathematics and Natural Sciences of Universitas Negeri Makassar (FMIPA UNM), Indonesia. Result analysis facilitates evaluation of online learning and their affecting factors, thus holding implications on education measures policy.

### WEAK POINTS:

The ideas presented in the paper are very interesting and the paper is well written. However, there are some open questions:

- The authors ask students about the devices that they often use to surf internet. And the students only have three options:

- 1) Desktop computer
- 2) Smartphone.
- 3) Laptop
- 4) Smartphone and laptop.
- 5) Android???

In our opinion, the options should be: i)Desktop computer ii)Laptop iii)Smartphone iv)Tablet PC (e.g., iPad, Galaxy Tab)

- The authors should ask students more about the factors affects to online learning than all about student's opinions such as "Who taught you most about how to use the Internet?", "Where do you usually access Internet?", "How many hours you go online per day?"...

Because it would be interesting to find out if the students usually use the internet at home or in school or public places (internet café) and how long they spend for surfing internet.

- Also, the references is very poor. The authors should consider incorporating a number of recent publications to be up-to-date

ADDITIONAL COMMENTS AND TYPOS:

- Specifications Table: "latitute" should be "latitude"
- Table 1: "Tahun" in Indonesian should be "Year" in English
- 2.2: "The data" at the end of paragraph should be removed

In conclusion, the paper can be improved provided that the authors answer the above-mentioned questions and modify the paper according to the suggestions.

Reviewer #2: Clear information is missing from the legends of tables 1 and 2, such as the meaning of some table items.

The authors mention that the data may be useful for the university studied and for the higher education in Indonesia, but this seems very limited; as perhaps the data may also be useful for other countries with similar characteristics.

At the Value of the data point there are some repetitions that must be corrected.

The link between data and industrial revolution 4.0 seems to me to be very forced and unnecessary.

The 6th column of table 2 seems unnecessary to me.

### The statement:

"Based on table 2, the majority of students (>75%) agree that the use of online learning media (heutagogy models) can increase creativity, fun, willingness / motivation, and ability in the learning process. And they can study anywhere and anytime without any limitations on space and time."

is very questionable, as the statements presented in table 2 only focus on (apparently) positive points about the use of ICT in the learning process, which induces a certain profile of responses. There are always limits and difficulties ...

Pay attention to the description of the point Sampling and sampling techniques and how it ends.
