Comments to the Author

The proposed paper aims to assess the relationship between knowledge of guidance and counseling services, attitudes towards guidance and counseling and performance in guidance and counseling activities in high school guidance teachers.

Major Revisions:

Introduction / Conclusion

A theoretical reference model to justify the hypothesis and the interpretation of the analysis conducted is not clearly indicated. This point should be better treated in the introduction and conclusion of the manuscript by broadening the theoretical background of reference.

Methods

It is not clear whether the measures regarding the "Knowledge on guidance and counseling" variable are self-reports or whether it is a skills assessment test, the same is true for the "Performance of Guidance teachers" variable. In any case, I think that the indices with which the variables of interest were measured should be better explained to make the interpretation of the results clearer.

Language

I am not a native English speaker, but I think that the language needs to be revised.

Minor revisions:

"Karatas, K., & Ismet, K. (2015). An investigation of the perceptions of school administrators towards the roles and duties of school counselors. Eurasian Journal of Educational Research, 61. " is not correctly cited in the text.
