1. Abstract:: should also include the originality of this study
2. Introduction (p-1)- *Why we choose qualitative stance? -Please use relevant sources when justifying*
3. *In many cases words run together. For examples: isregarded; consumerstoward. This is visible throughout the paper. Need serious editing*
1. Personality factors (page-2): The author(s) have provided a lot of factually sounding material that could have provided an interesting element to the paper. However, due to the absence of references it becomes difficult if not impossible to verify the content of this section. I strongly recommend that the section to be revisited and all factual statements be referenced.
4. Methodology: Please explain how these 84 customers were selected and the nature of questions were asked
5. Discussion: In discussion please compare and contrast the findings with current literature so that the readers will get a clear insight about the findings and originality

**Editing & proofreading:** The entire paper needs to be seriously edited and to observe grammar and mechanics of the English language and improve the quality to make it readable. The revised version should be proof-read thoroughly if necessary by a native English speaker
