In summary, this analysis suggests that a combination of community engagement, education, inclusive planning, active leadership, responsible media representation, and economic inclusion forms the foundation of effective strategies for promoting social integration in multicultural urban environments.

Analysis of Future Directions for Urban Multicultural Societies

The analysis of the sixth research finding provides insights into the future trajectories of urban multicultural societies in the context of social integration and sustainable development. The study's projection that cities will continue to grow in cultural diversity aligns with Sassen's (2012) observations on the increasing urbanization and globalization trends.
