

From these data illustrate that the first order of Internet users, ages 35-44, as many as 29.2% (to 38.7 million the number of respondents), second, ages 25-34 years, as many as 24.4% (with 32.3 million the number of respondents), third, age 18.4% (to 23.8 million the number of respondents), and fifth in 55 years and over 10% (by number of 13.2 million people).

Seen that internet users in Indonesia, children in third place, means and stressed that the involvement of children in cyberspace is very large.

When examined more closely, Very concerned against the surf safety data with the results of the survey APJII.

Various forms of crime in the virtual world, which is very alarming is the target of the crime is a child that should receive serious attention from the government, it can take a look at the news <http://news.liputan6.com/>, reported under the title "Children often Reveal Crimes, Criminal Achieves". The contents of the news says that the Criminal Investigation Police received an award from the Ministry of Women's Empowerment and Child Protection (PP and PA). The award was received by the Criminal Police Commissioner General Ari Dono Sukmanto. The Ministry of the PPA to prioritize the prevention of child sexual crime more intense. Starting from pedophile cases, sexual abuse to child exploitation. "Crime in the field of child pornography and pedophile, for example, is increasingly worrisome, so prevention

must be a common concern. This forms the state's presence in the midst of the people. At the moment we are making in the form of policy-making oriented protect children.

Indonesian Child Protection Commission (KPAI) noted the evils of pornography and cybercrime against children increased in the period of three years back. Commissioner KPAI Pornography and Cyber Crime Division Maria Advianti said, in 2014 to 2016, there were at least 1,249 reports entered. "This number increased when compared with data 2011-2013, reaching only 610 reports.

KPAI deliver increasing reports of pornography and cybercrime in conjunction with the large number of children who use the internet. The research results of UNICEF and the Ministry of Communication and Information, published in 2014, 30 million children and adolescents Indonesia intensive use of the Internet. "They are intensely five hours a day using the Internet," said Maria. "If the child is less understanding of the use of the Internet, children can become victims of crime on the internet.

So, crime in cyberspace, one of which includes sexual crimes online. One of the cases highlighted in Jakarta KPAI is a pedophile in action through social media. The modus operandi was the perpetrator targeting minors with seduction that was brought through social media.

From the description above, the authors conclude that the various forms of crime has an impact on the social environment in maintaining the safety of self and the cultivation of moral values to children. Therefore, the role of family environment, especially parents, schools and communities to protect children from Internet crime is indispensable.

Factors resulting in the Field of Information Technology Crimes Against Children

From the description above, by discussing the forms of information technology crimes against children, illustrate that the presence of cyberspace (Internet) give a negative effect on children with various forms of crime inflicted.
